1.) The Mare Owner hereby agrees to purchase cooled semen at the following breeding fee: US \$ 2,000.00 for Cabardino, plus shipping & handling cost of \$ 250 for a total payment (including shipping cost) of US \$ 2,250.00 for Cabardino. Signed contract and Payment in full have to be received by the stallion owner before any semen can be released.

2.) It is recommended that Mare Owner contacts the Stallion Owner at least one week prior to expected date of shipment of fresh semen to give advance notice. Semen order specifying mare owner's name, stallion's name and confirming shipping address has to be received by text to 519-801-2000 ideally the day before we need to ship semen. Semen will be shipped by Fed Ex & delivered the following day by 5:00 p.m. We collect stallions & ship semen on Mondays, Wednesdays and Fridays. We are shipping one dose of semen. In the unlikely event that more requests for semen are being received than semen can be shipped, requests will be filled in order they are received. We will make every reasonable attempt to fill last minute semen orders.

3.) Mare Owner warrants that said Mare is in sound breeding condition as determined by a qualified veterinarian. Mare Owner agrees that Mare will be bred by Veterinarian with considerable experience in A.I. who has access to a veterinary ultrasound machine.

4.) Should Mare fail to be in foal after initial insemination, Stallion Owner agrees to ship cooled semen for a repeat service **AFTER** receipt of I) signed veterinarian certificate confirming that mare is not in foal and ii) payment of \$ 450.00 to cover collection and shipping fees. For Cabardino we reserve the right to ship a maximum of five times (incldg. initial shipment) at these fees. Mare is entitled to return breeding privileges for one season. Mare owner is responsible for a re-booking fee of \$ 300.00 at the beginning of the second season. Should the mare not be in foal, the contract can be transferred to a different mare with the consent of the stallion owner. Mare owner needs to supply a signed veterinarian certificate confirming that mare is not in foal and pay a transfer fee of \$ 350. Contract cannot be transferred to a different mare if we have shipped semen five or more times for the original mare. Shipping and collection fees apply for all repeat shipments.

5.) Should the stallion die, become unfit for service or be sold, to fulfil this contract, the contract will be transferred to another stallion standing at W. Charlot Farms that is available for collection. If no other stallion is available, the stallion owner will supply one dose of frozen semen to the mare owner to fulfil this contract. Applicable repeat/shipping/tank rental fees will have to be paid by the mare owner.

6.) Both parties acknowledge that there is a live foal guarantee for all mares NOT OLDER than 17 years of age during 2024. Onus is on mare owner to submit proof of age (valid registration papers). There is NO live foal guarantee for mares older than 17 years during 2024 or for semen used to flush embryos and the repeat service is limited to a total of five shipments. Collection and shipping fee will be \$ 600.00 for fourth and fifth shipment for mares older than 17 years of age and for semen used to flush embryos. For live foal guarantee to be valid, the following conditions must be met:

- a) A licensed veterinarian must examine the Mare and advise Stallion Owner in writing of the mare's pregnancy status within 50 days after the last insemination date or by August 31,2024
- b) whichever comes first. If this notification is not provided, the live foal guarantee and return breeding privileges of this contract becomes null and void.
- c) Should the mare not produce a live foal (i.e. a newborn foal that stands and nurses), the mare owner is entitled to return breeding. This guarantee shall only apply if the stallion owner is notified in writing within 72 hours of the foal's death. A statement of details by a licensed veterinarian must follow within 10 days or the guarantee becomes null and void. This clause is also binding in case of abortion. If the mare resorbs her pregnancy, we need written verification of this fact from your veterinarian.

7.) This agreement is binding upon the parties herein and reflects the entirety of their agreement.
