This agreement is made for the 2024 breeding season by and between W. Charlot Farms Limited (hereinafter "The Stallion Owner") and \_\_\_\_\_\_ (hereinafter "The Mare Owner"), for (mare).

- 1.) The Stallion Owner hereby agrees to sell the Mare Owner frozen semen of (please select one of the following options) \_\_\_\_\_stallion Cabardino \_\_\_\_\_stallion Viva Voltaire

2.) The Mare Owner hereby agrees to pay the fee of (please select one of the following two options)

- i) US \$ 750.00 per dose for a total of doses (min of two) of the stallion Cabardino
- ii) US\$ 500.00 per dose for a total of \_\_\_\_\_ doses (min. of 2) prior to shipment of semen of the stallion \_\_\_\_\_ Viva Voltaire (please check off stallion).

3.) Semen will be shipped out of Yancey Farms in Fredericksburg, TX and mare owner will make shipping arrangements directly with Yancey Farms by calling Judy Yancey at 1-800-867-7021. Semen will only be released once W.Charlot Farms has received payment for the doses.

4.) Mare Owner warrants that said Mare is in sound breeding condition as determined by a gualified veterinarian. Mare Owner agrees that Mare will be bred by Veterinarian with considerable experience in frozen semen artificial equine reproduction who has access to a veterinary ultrasound machine.

5.) Should said Mare not be in foal after insemination with initial two doses, the Stallion Owner agrees to release additional doses of semen at reduced price of \$ 400.00 per dose for Cabardino and \$200/dose for Viva Voltaire to the Mare Owner during the 2024 breeding season upon receipt of signed veterinarian certificate confirming that mare is not in foal following insemination with initial two doses. A maximum of four doses (including first shipment) will be sent for any one mare. Straws purchased at full price can be used to inseminate more than one mare. Please advise W.Charlot Farms prior to August 31, 2024 of any mares bred in addition to the mare noted below so that we can include them in our 2024 breeding report filed with various breeding associations.

6.) Should said mare not be in foal after insemination with initial two doses or any additional doses purchased, contract can be "up-graded" to cooled semen live foal guarantee contract for Cabardino at a fee of \$ 1000.00. There is no separate collection or shipping fee for the first collection. Terms and conditions of 2024 cooled semen sales agreement as posted on stallion owner's website will apply.

7.) This agreement is binding upon the parties herein and reflects the entirety of their agreement. Both parties acknowledge that there is NO live foal guarantee unless contract is "upgraded" as per paragraph 6 above.
